The Johnson Fund

The Johnson Association supports about 70 of the retired, sick or infirm Priests of the diocese. This is done through grants that are made to them.

Priests who are sick receive financial support during their period of illness. Priests who have retired apply for a discretionary grant which will support them throughout the retirement. Last year (2018/19) the Johnson Fund paid £382, 266 in grants. The average age of a priest in the Archdiocese is currently 62 yrs

This means that the number of Priests applying for a grant will grow as priests are due to retire in the next 10 years. The "Johnson Fund" was originally founded in 1710 with a small sum of money left by the Rev Daniel Fitter to provide for the needs of the clergy in sickness or old age. The Associations owes its name to the first administrator who was the Rev John Johnson (1711-1739).

This year we are trying to raise your awareness of the Johnson Association .especially in this newsletter and the posters and display stands in your Church.


The Johnson Association AGM

The Trustees of the Johnson Association understand the importance of good governance. Throughout the year they devote time to Trustee Training and systematically review every aspect of the governing role of the Charity. Over the last year the last trustees' studied the "Charity Governance Code".

Fr Paul Fitzpatrick has been appointed our Data Manager.

The Data we hold is contained in the Grant Application Form, which maybe special category personal data. We do not divulge any of this data to any third party (unless required by law). The reason we hold this data is to enable us to pay your grant. You have the right to review the information we hold about you, and to have it removed -

but please be aware that without these records we may not be able to continue to pay your grant.

The Secretary and Administrator

The Administrator is the point of contact for those Priests who have retired, or are about to retire. He also works closely with the Chair of Trustees and manages the day to day financial organization of the Fund. He organizes the Annual General Meeting.

The Secretary is the point of contact for the

benefactors and members of Johnson Association.

He ensures that the Masses are distributed to each of the members and ensures that they have notified the association after these Masses have been celebrated.

It is YOUR data that we hold, and our policy is outlined in our Privacy Notice which will accompany this newsletter.

A Financial Update

At the AGM our auditors and financial advisors make their annual report to the members. At the 31 March 2018, our Total Funds were £15,169,554.

This included seven legacies totalling £26,556; Investment income of £393,411; other expenditure was as high as 8%. donations and appeals of £146,962.

Charitable Activities—Expenditure was £399,725. Grants paid was £367,201 and other expenditure was £32,524. This means that 92% of our expenditure is on grants for Priests.

We currently hold no property as we sold a house earlier this year, and re-invested the income.

This resulted in higher than usual Solicitors and Estate Agents costs, which is why our

Our designated Funds (those within our portfolio at 31 March 2018) was £14,471,126.

The Trustees of the Johnson Fund review the Financial Risk to the portfolio at the start of each year. Our current risk level is MEDIUM.

Every Church in the Diocese has a been given new Gift Aid envelopes and an attractive stand within which they will stand. We would be most grateful if you could use the Gift Aid envelopes as a means of making donations to the Johnson Association.

Each year on the first weekend in November there is the annual second collection for the Johnson Association.
